## Legal Defense Plan

Active PPOA members are provided with defense coverage for civil and criminal actions arising in the scope of duties.

## Peace Officers Relief Fund (PORF)

All active, full-time LA County employees who are sworn peace officers as defined by California Penal Code Section 830.1 and belong to collective Bargaining Unit 612 (LASD/LADA Sergeants and Lieutenants) are participants at no cost. PORF includes:

Long Term Disability — After 90 days of continuous disability, under the care of a licensed physician, the monthly benefit is 60% of Basic Gross Monthly Earnings up to a maximum of \$4,300 or a minimum monthly payment of \$100.

Life Insurance — A benefit of \$100,000 is paid for loss of life.

## POPA Federal Credit Union

Established by PPOA members in 1977, the credit union is full-service, nonprofit and member-owned, with more than \$170 million in assets and four full-service locations in Los Angeles County.

## PPOA Insurance Agency

PPOA members have access to an array of plans designed to complement County-provided benefits, including disability income protection, critical illness, accident expense, homeowners, auto, boat and more.

## Negotiations

PPOA is the exclusive bargaining agent for Unit 612, 614, 621 and 631/632. PPOA members in these units negotiate for wages, hours and working conditions and only PPOA members have the right to ratify contracts.
