ike many of you, I was horrified when I learned of the tragic death of Riverside County Sheriff's Deputy Isaiah Cordero, On December 29, 2022, the 32-year-old approached a vehicle he had stopped when the driver pulled out a gun and opened fire, fatally wounding Deputy Cordero. The suspect fled the scene and led deputies in a vehicle pursuit, where he was shot and killed after he opened fire on deputies. He had a lengthy criminal record and stabbed a California Highway Patrol canine in 2021. At the time of Deputy Cordero's murder, the suspect was out on bail even after having been arrested for failing to appear while awaiting a mandatory 25-years-to-life sentence for the incident where he stabbed the canine. Deputy Cordero had served with the Riverside County

Sheriff's Department for eight and a half years and was a motorcycle deputy assigned to Jurupa Valley. He is survived by his parents and stepbrother.

Before the community and fellow law enforcement colleagues could finish mourning Deputy Cordero, a second tragedy hit the Riverside County Sheriff's Department. Deputy Darnell Calhoun, 30, was shot and killed in the line of duty on January 13, 2023, while responding to a call involving domestic violence and a child custody issue in Lakeland Village. Deputy Calhoun began his service with the Riverside County Sheriff's Department

as a Deputy Sheriff in February 2022 and was assigned to the Lake Elsinore Station. He had previously served at the San Diego Police Department for two years. Deputy Calhoun was the father of two boys, ages 2 and 4. In addition, he and his wife were about to welcome a third baby boy.

Although these two tragic incidents occurred outside Los Angeles County, they still hit home and serve as a reminder that law enforcement, specifically the men and women who proudly serve their communities, are targets of offenders enjoying the lax criminal system.

On behalf of the entire PPOA organization, we extend our deepest sympathy to the families of Deputy Isaiah Cordero and Deputy Darnell Calhoun.

PLANNING AHEAD FOR PPOA

One of the most important and impactful responsibilities of an association's board of directors is to develop a strategic plan to lay out short- and long-term goals. Last month, the PPOA Board of Directors and I attended a yearly Board planning session. We convened for three days and listened to several subject-matter experts who presented on various subjects such as insurance benefits, workers' compensation laws, Senate Bill 2 updates, legislation updates and the Public Employees' Pension Reform

> Act (PEPRA). In addition, we had rich discussions on how to expand our perspective and help discover new ideas and solutions.

For example, some of the solutions discussed for PEPRA were for the Board of Supervisors to support a 401(k) for non-mega-flex employees, implement the DROP program (it would be an offset, and the County would save on workers' comp) and/or legislative change (increase the salary cap). If you would like to read further on PEPRA and the DROP program, please see Board member Jim Schallert's article in the January issue of Star & Shield magazine, in which he diligently explained both topics.

Lastly, I welcome the recently promoted Sergeants who began their new roles on January 15. During the badge exchange, I saw a lot of friendly faces and met new folks, all eager to take care of business at their new units of assignment. It was a pleasure to speak with them and answer their questions regarding the many benefits that come with PPOA membership.

want to start my message by acknowledging and saluting the Riverside Sheriffs' Association (RSA) for their extraordinary leadership as they have faced the heartbreaking mission of honoring two of their fallen heroes, Deputy Isaiah Cordero, 32, EOW: 12/29/22, and Deputy Darnell Calhoun, 30, EOW: 1/13/23. In a two-week period, the RSA has faced the unthinkable, and yet in each tragedy, they have responded with a determined and unwavering commitment to their organization's motto of "Serving Those Who Serve."

I would be remiss if I didn't also recognize Riverside County Sheriff Chad Bianco for his exemplary leadership during both horrific incidents. Sheriff Bianco and Deputy Cordero's family have called for the resignation

of San Bernardino Superior Court Judge Cara D. Hutson for allowing the murder suspect (deceased) back on the streets despite a third-strike conviction in November 2021.

I know the RSA, as well as other police and sheriff's associations throughout California, does not seek accolades for

the incredible contributions and usage of resources they make when one of their members makes the ultimate sacrifice. But to be certain, the RSA, led by President Bill Young since December 2017, deserves immeasurable gratitude from the residents of Riverside County, the Riverside County Sheriff's Department and the law enforcement community throughout California for never forgetting their fallen heroes and their families left behind.

The Star & Shield Board of Directors meets every month to review all requests as well as to review fundraising events. The number one fundraising event for the Foundation is the annual PPOA Peace Officers Memorial Golf Tournament. This year, the 15th annual tournament will be held on Monday, June 5, at Friendly Hills Country Club in Whittier. This annual Memorial Golf Tournament is a premier golfing experience and sells out every year.

Moving Forward

he saying goes that progress is a slow process. And historically for Custody Assistants, it seemed that way, or that there was no progress at all.

I've sat in meetings and heard Lieutenants say, "Can't they just refuse the assignment?" when talking gas masks and ERT deployment. Or, in regard to safety equipment, they reply, "You should negotiate for that."

Our safety was not to be negotiated. Either provide the equipment or change the policy and assignment. More reasonable people came together to resolve those nonsensical statements.

Now that we have new leadership, there will be new conversations with the hopes that rational perspective will supersede an old-school way of operating.

I have met with Sheriff Luna and briefly discussed the staffing concerns of not only custody, but our station jails as well.

Over the past year-plus, we have seen an increasing number of Custody Assistants (and Security Officers) move onto

fall guy behind a 902 or 902A. Especially now that zero bail is gone and the public and politicians are realizing, although not publicly stating, that the softened stance on crime only led to less time and more crime.

Custody is feeling the strain as well. With more inmates entering the system at a near pre-COVID rate, mandates still in place, items still being loaned out and basic Title 15 needs to be met, facilities are operating short-handed. And once you've become accustomed to that, it becomes the norm while CARP continues to be *an* answer, but not *the* answer.

With that, we are scheduled to resume our Labor Management Committee (LMC) meetings with the Assistant Sheriff of Custody. Here is where direct conversation on these matters will take place. These

monthly meetings are scheduled to resume on February 1.

The Custody LMC has been a beneficial tool in exchanging information, confronting problems and resolving issues. We value this opportunity and hope the new regime takes in the value of having these discussions. Issues do not get resolved overnight, but ideas are exchanged, reasons for or against an idea are given and fact-finding leads to possible compromise and resolution.

The Sheriff has made the rounds and is open to understanding that there is a uniqueness about the C/As in how they are utilized in comparison to the classification's origins and evolution.

I will continue to consult with legislative and legal resources going forward, knowing that you need to cite references when making a presentation.

Lastly, COVID mandates. The County still has the right to institute a mandate. All legal challenges thus far have failed. Governor Newsom is still scheduled to lift the COVID-19 state of emergency order on February 28. At that point, it is anticipated that many challenges to everything will take place.

Contrary to rumor, PPOA has been involved legally throughout, with the defense of membership always being the priority. Our attorney, Jim Cunningham, meets with the Department weekly and has been to court against the County and continues to be prepared for when the emergency order is lifted. Exemptions have been approved, and to this point no member has received discipline or termination.

Make time for family, look out for each other, be informed and be safe. ♥

the DST Academy. That is good for the individuals and the Department, as they have heeded our outcries of the perceived and often proven notion that an "off-the-streeter" was more preferred than a seasoned C/A.

Nevertheless, with that comes the continued need to replenish the classification. Class #108 is currently in the Academy and scheduled to graduate on March 10.

There was also talk of the documented outdated staffing model for station jails and the need to seek options and funding for additional items.

You cannot continue to heap mounds of work, policy changes and mandates on a line jailer and make him/her the

reetings, everybody. It's hard to believe we are only a couple months into the new year and are already extremely busy. Some members have asked about the status of Academy classes for SSOs. Personnel representatives have informed PPOA that no academies are currently scheduled. When the Department removed the requirement for associate degrees for deputies, many, if not all, future candidates moved their process to DST. With that in mind, I want to say thank you for the work you do keeping the public safe and, most importantly, ensuring you and your co-workers make it home at the end of the day. And to those picking up overtime to help other bureaus, thank you.

We are trying to set up a meeting with Sheriff Luna to express our concerns and follow up with ideas. He expressed much enthusiasm about working together with the unions, but we also understand he is trying to see the mechanics of this

complex machine (LASD) that keeps moving forward every day.

Vests are in stock at Logistics, so please get yours exchanged. If you have a Generation #1 MP9, make sure to take it with you to exchange for the Generation #2. And please prioritize making an appointment to get your vest exchanged. PPOA will also be working with the Department to come up with additional locations to do the exchange being that the County is so large and Logistics is only available during certain hours. We conveyed member concerns about the difficulty of traveling with no coverage at some assignments. I'll update members as I get more information.

I've mentioned this in a past article, but I want to remind you to double-check your Department information. Everybody needs

to be up to date. Do this for your loved ones, your co-workers and the safety aspect of it all. For example, think about your life insurance, health coverage and emergency paperwork. Please don't let procrastination prevent you from getting this done.

Last month, PPOA Board members gathered for the annual planning session, and we anticipate sending out more information to keep members informed. We discussed several issues, including member safety, protection, career survival, 4850 time, IOD issues, SB 2 and more.

If you have questions about union issues, make sure to contact me or any PPOA Board member. And please be wary of rumors and hearsay that always find a way to spread so quickly around the workplace.

Last month, County Services hosted training, and I am pleased to see the Bureau taking the initiative to do extra training. Kudos to everyone involved with that. In addition, I had a chance to speak with many of you regarding occurrences throughout the Department.

Some of you have reached the halfway point of your career and some are well beyond that point. Make sure to check on your progress with LACERA and Horizons. We hope to once again host retirement workshops in the PPOA conference room and maybe, with the help of LACERA, we can bring the information to a location near you.

As we gear up for what will definitely be an eventful year, I want you to rest assured that PPOA is monitoring the changes in the Department and County, and we will provide support for members as concerns arise.

As we get into the warmer months, I will make visits to various units to listen to concerns and address any rumors. As for now, stay safe and practice with the tools given.

My View of What Our Union Should Be — 30 Years Later

n 1992, I was a young Crime Analyst with six years in the Department when I was elected to the PPOA Board. Never could I have imagined 30 long years later I would be elected to return to the PPOA Board. It should be interesting to see how things have changed!

I am a Christian, a father and a proud union member. I am also an incredibly proud and devoted L.A. County Sheriff's Department member. Reporting to East L.A. Station so many days per week and being surrounded by the quality of people I encounter daily is a huge blessing. If you don't get what I mean, apply for a parttime job for a week. Go work in retail, a restaurant, a car dealership or an insurance office, and you will be amazed at the nonsense that goes on and how people treat

each other. Ask your non-Department-member spouse how work was! Try waiting tables. Try teaching a class of angry kids afraid to take their masks off! We are one really lucky group of people. That's why I am back involved in my union. Your union. Our union. Without this union, we would be in a world of hurt. My goal 30 years ago and to this day is to make PPOA and LASD a better place.

Please let me share why I feel it's important that PPOA maintains its purpose — to be a labor union. President Biden proudly made clear to the American public, from the earliest days of his campaign to his most recent intervention in the potentially disastrous railroad strike, that he is the most outspoken supporter of unions and collective bargaining in American history. He added that no one has ever occupied the Oval Office who was stronger on labor and union issues than him. On his first Labor Day, he called unions vitally necessary "to counter corporate power, to grow the economy from the bottom up and the middle out." I love this quote. The salaries and benefits unions have secured for law enforcement in California are among the highest in the nation.

This is what I want every member of Unit 621 who returned me to the PPOA Board to understand about me. This is what I believe PPOA should be doing — bringing superior wages and working conditions to law enforcement professionals while protecting them from external and internal threats. This will come through education, assertive leadership and a smart Board with smart leadership.

I implore every Department member, especially my younger, less experienced Unit 621 members, to understand why unions are so important. They may not realize that this was all about something we long ago lost interest in





because we are so used to it. It's those 12 days of sick time that your union — PPOA - negotiated for you so many years ago. Because rail workers don't get paid sick days, they are forced to use vacation time instead. Since vacation time needs to be approved in advance, workers are often compelled to work when they come down with an unexpected illness or medical emergency. Can you imagine having those kinds of terrible policies being inflicted on us? I was on the negotiating team when we went from eight to 12 sick days, and no matter what union busters say, PPOA is not going backward. We aren't giving up a thing. The heroes I work with, well, I got their back.

Ongoing Assessment of Senate Bill 2

enate Bill 2 (SB 2) is a legal reporting requirement that officially went into effect on January 1, 2023. It requires law enforcement agencies in California to report certain events involving peace officers they employ, as specified in 12510.9 PC. The new law also requires peace officers in California to be certified by the Commission on Peace Officers Standards and Training (POST) to serve in that capacity and provides a new mechanism by which POST may review alleged misconduct by a peace officer. Ultimately, POST can decide whether to suspend or revoke the officer's certification.

PPOA representatives and union legal counsel met and conferred three times in December 2022 and January 2023 with LASD executives and members of the LASD SB 2 team regarding the Department's requirement to report serious misconduct to POST. We also met to discuss this issue with DA's Office executives last month and are scheduled to meet with Department of Medical Examiner-Coroner representatives by the time this publication reaches members.



All Sergeants and Lieutenants are encouraged to review any Department communication regarding SB2 as well as updates issued by PPOA.



Devil Pups Youth Program for America

he L.A. County Sheriff's
Department will again be able
to send exemplary boys and
girls who are 14 to 17 years
of age to a 10-day citizenship/leadership
program at Marine Corps Base Camp
Pendleton this summer. We hope our
boys and girls will be prepared physically
and academically for the testing and the
camp. Good grades are a necessity.

This program normally runs at the same time summer school is in session. If your child will need to attend summer school to graduate, attending this camp will be a conflict.

As part of the Devil Pups good citizenship training, boys and girls will learn the importance of the following virtues:

- Honor: to be respectful to your family, country and each other
- Courage: to set and pursue personal goals
- Commitment: a promise of resolve to recognize the value of completing your education

The U.S. Marine Corps was given the name "Devil Dogs" in World War I by enemy troops due to the Marines' accomplishments on the battlefield and "never give up" spirit. The Devil Pups name is derived from this Marine Corps history. The camp has been in existence since 1954. The Sheriff's Department has been able to send exemplary boys and girls to this citizenship/leadership program because of generous support from:

- Association for Los Angeles Deputy Sheriffs (ALADS)
- L.A. County Professional Peace Officers Association (PPOA)
- Sheriffs' Relief Association
- First City Federal Credit Union
- POPA Federal Credit Union

The orientation and physical qualifications testing will be conducted on Sunday, April 30, in the Biscailuz Center gym. The orientation will answer many of the commonly asked questions. All interested applicants must take a physical agility test, including sit-ups, push-ups, pull-ups and a one-mile run. Participants should eat at least one hour prior to arriving and wear gym clothes and running shoes for the physical agility testing. All applicants must also bring a container of water and/or sports drink. Parents are encouraged to also bring bottled water, pencils, a clipboard and blanket if they wish to sit down on the grass while their child participates in the physical agility testing.

Boys and girls must be in good health and physically able to participate in the strenuous physical requirement of the camp. Asthma or other respiratory illnesses will preclude participation in this camp.

Note: This year, there will only be one Devil Pup encampment. We are notifying everyone early so that Department applicants will have time to prepare physically. It is mandatory that participants bring their parents or guardian to the orientation. Department sponsors must also attend if they are sponsoring a close friend and parents who are not on the Department. For split families, the custodial parent will have to sign the agreement paperwork. It is important that parents, guardians and sponsors attend the orientation and testing to see firsthand what is involved. Also, our boys and girls need the support of their loved ones on testing day.

At this time, it is not necessary to schedule boys and girls prior to this testing date. Boys and girls, parents, guardians and sponsors need only be prepared for the testing.

The program continues to be free to boys and girls who are sponsored by

Department members. Department members are encouraged to sponsor their relatives and close friends. Due to a very limited allotment, we will not be able to select boys and girls who are not sponsored by a relative or close friend on the Department.





Five Steps to Organizing Your Finances

o you know your net worth? Or how much you spend each month, and on what? Or how much you can expect from your pension plan or Social Security in retirement? A majority of the population will answer "no," saying they've been too busy with life to get a handle on their finances.

Fortunately, there's a five-step action plan to help you take control of your money.

SET UP A FINANCIAL FILING SYSTEM EITHER MANUALLY OR ONLINE

Keep separate folders for different expenses and records, for instance, "Auto Expenses," "Insurance," "Mortgage," "XYZ Credit Card," etc. There are also many online apps that will allow you to do this electronically.

GATHER RECORDS

Look through your records to identify missing information. For example, you need an estimate of your Social Security retirement benefits. To request one, visit SSA.gov or call (800) 772-1213. Gather copies of your health, disability, life, homeowners and vehicle insurance policies, and get a copy of your credit report. You can check your credit report — the summary of your credit activity that generates your credit score — from each of the three major credit reporting agencies once a year for free. Always make your requests from annualcreditreport.com, the only website sanctioned by the Federal Trade Commission. Make one request every four months in rotation among the three credit agencies so you can monitor your credit report year-round.

SIZE UP YOUR SITUATION

Add the estimated current value of all assets, including your home, car, personal property, savings, investments and retirement accounts. Next, add all liabilities, including mortgage, credit card balances and any other outstanding debt. Subtract the liabilities from the assets. This tells you your net worth. Then, make a list of income and expenses by reviewing paycheck stubs, online checking account information or your checkbook register, and credit card statements from the past year. Finally, track spending for a month by saving all receipts or recording cash purchases in a notebook, or use one of the many expense trackers or money management apps that can help organize spending by category.



CHART A COURSE

Set financial goals — long term and short term — and figure how much money you'll need for each. Create a target saving and spending plan that meets your needs using your list of income expenses. For a month or more, track actual spending to see how you're doing, making changes as necessary.



HISTORIC LASD BADGE AND BUCKLE

Description provided by badge owner (retired LASD Lt.): L.A. County Sheriff's badge, circa 1932, number 12.
