# Three Tips to Thrive in Your Retirement: A New Chapter Begins

n behalf of PPOA, I had the honor of attending the annual LASD Retiree Roundup in Laughlin, Nevada, this past April. With a retired membership of 3,382 individuals, PPOA is a proud sponsor of this event! This was my first time attending and it far exceeded my expectations. The camaraderie was aweinspiring. It was great to know that, in addition to the regular luncheons and local gatherings our retirees attend, there exists this large-scale "Roundup" space each year for us to maintain and renew the decades-long connections we have established within our LASD family.

In 1997, retired Sergeant William "Moon" Mullen, who had since moved to Arizona, saw the need for connecting retired LASD members, many of whom felt far removed from the

Department as the years passed. It was apparent to Moon that the answer existed in compiling an LASD retired email list. He started with 40 names, and it has now grown to nearly 4,000 members.

Originally, Moon sent out messages to all members of the list, including Department bulletins, bereavement notices, sick notices, retirement notices, job opportunities, requests for assistance, personal messages from retired members, techniques for connecting with long-lost partners and other items of interest. It was not long before his efforts grew into what we now know today as the annual LASD Retiree Roundup in Laughlin. As word travels about this fantastic event, attendance has grown steadily year to year.

When I attended this past Roundup, I was pleasantly surprised to see many retirees whom I had worked with in the past, as well as an ample number of active members who attended in support of their retired spouses and friends. There was plenty of time built into the event to visit with other attendees and even build new friendships.

I especially enjoyed the many tidbits of wisdom and experience passed on to me at the Roundup as keys to a successful retirement. There were many commonalities I gathered as I talked with our retirees about ways to create a thriving retirement. While the formula for a successful retirement is unique to each person, three tips stood out to me:

- Health is wealth: As law enforcement personnel, the nature of our profession often positions us to retire well before other career paths. This is due to the toll the job has on our minds and bodies. Exiting this career path with suitable medical and disability coverage is paramount. We need to be able
- to sustain our health long-term in order to get the return on investment (ROI) for our years of service. In addition to the 25-year full coverage threshold, we must start the process of gauging our medical needs at least three years prior to our retirement date. Post-retirement is usually not the time to assess those needs, and options become more complex.
- Finance the future: Pension structures throughout the state and nation are constantly enduring the threat of being dismantled. We are fortunate to have one of the last remaining systems of pension funding that acknowledges our contributions to Los Angeles County. Based on our years of service and age, how much do we really need to sustain a comfortable retirement lifestyle? According to financial planners, about 75% of our gross annual income is needed post-retirement. But recognize that this is the national average. Living on 65% may be suitable for those considering retiring in Katie, Texas, where the cost of living is far below that of California. If you want to travel the world for six months of the year, perhaps 90% may be more suitable. The choice is yours, and it involves setting realistic expectations about exactly how and where you want to retire.
- Get a job: Before sulking at this suggestion, please understand we are not referencing a "job" in the traditional sense of the word. It is important to have a mindful intent during your retirement. Upon retirement, whether your "job" is professional grandkids transporter, amateur chef, Little League coach, deep sea fishing trip organizer or book club facilitator, have a purpose-driven lifestyle that engages you socially on some level. Many of us have spent more than three



decades with our lives encompassed by a career we have treasured. When that career ends, we can be left with anxiety, frustration and loneliness. In her book, Surviving Retirement, Dr. Medina Baumgart (a board-certified police and public safety psychologist) candidly details the mental challenges her husband faced when he retired from an illustrious law enforcement career. The lesson: Find a purpose in your retirement.

At PPOA, we pride

ourselves on preparing our members for retirement. Several times throughout the year, we bring together a panel of experts at our union office in San Dimas. The seminar usually fills up quickly and works on a first-come, first-served basis. PPOA members interested in setting themselves up for a well-earned retirement file into our union conference center. Speakers on hand deliver relevant advice on a wide range of topics.

# **Retirement in California: Should You Stay or Should You Go?**

s we learn more about the "state" of California, or the state this state is in, it is clearer and clearer that many policies and laws passed in the past 10 years don't work as intended. There is finally a good chance that Proposition 36 may pass. I encourage you all to read it and support it. It addresses some, but not all, of the failings of Proposition 47, which everyone reading this knew would not work out. Please read that and tell your family and friends to vote for it. This November, it's yes on Prop 36 and no on another DA Gascón term!

The LASD is in a real employment mess. The profession has lost the attraction of our youth these days, and other agencies are offering tens of thousands of dollars in signing bonuses. One Southern California

agency is dangling a \$100,000 bonus. We are already well behind other agencies like LAPD, when you consider they have the DROP program and their pension system is not subject to the Public Employee Pension Reform restrictions like LACERA. It will be very hard for our new members to retire at the same ages we did — 65 will be the new 55. Sheriff Luna has a huge mountain to climb if he wants to fix the staffing issues. Academy classes used to be 75 to 100, and now they are happy if they get 40.

Many people have left California immediately upon retirement, and I am not sure if taxes or politics play into that

# Acknowledging the Legacy of a Supervisor Who Stood Above the Rest

ith this issue being dedicated to retirees, this is a great time to share a story about a recent retiree who made a huge impact on me, everyone he worked with, the entire Department and the citizens he spent his life protecting.

One of the many great things about working for this Department is the quality of leaders we encounter. While we all have had bosses or supervisors who we cannot believe have any authority at all, it's still rare. Because of the changing attitudes of workplace behavior and a younger mindset that relies more on technology to communicate than anything else, the days of big retirement parties and off-training parties seem to have faded drastically, leaving us with nowhere to really honor those people who made an impact on us.

We all have had that one supervisor who just stands above the rest the kind who works twice as hard as the team they supervise, who isn't afraid of mentoring and leading, but also will fight harder than ever to support and protect the people the Department trusted them to watch over. Anyone who worked Pico Station in the late 1990s and early 2000s is probably thinking of the same name I am. For me, the man who rises as the best Sergeant, best Lieutenant and best overall Deputy Sheriff who I ever encountered was a man who passed away in July. Sadly, he only enjoyed six years of retirement before cancer cruelly cut his life short, but I considered it an absolute honor to work with the late Kevin C. Lloyd during his career as a public servant.

Kevin was one of a kind.

He expected the best work from the people he supervised, and while they may not have always appreciated his hard-driving style, he got things done.

In the early '90s, there was a highprofile incident in Pico's area involving a well-organized attack by a local gang on the home of a Pico deputy. This not only was outrageous by societal standards, but also so offended Kevin that he organized a task force to crack down on the attackers (even though the deputy was not physically harmed), and he selected an elite crew to show the community that this outrageous attack would be avenged.

I was assigned to Norwalk at the time, and since the two stations were somewhat merged in those days, I got asked to help organize some of the information into

computer databases. Spending time with Kevin's crew was intense and amazing. He led them with such ease and

passion. It was a sight to see. When some dumb rivalry issues led to the Norwalk resources being ordered to stop going to Pico, I was put into one of those "moral quandaries." Do I disobey a direct order and risk discipline, or do I continue to assist Kevin in ways that the Norwalk brass would not notice? It worked. Also, seeing at how Kevin went to bat for his guys, I knew he had my back. Eighteen months later, when a Crime Analyst spot opened, I felt proud to be working for Kevin Lloyd again, this time "on the books."

Rest in peace, Kevin Lloyd. All of us are better for knowing you. •



## **LEOSA: Retiree Testing Procedures**

he purpose of this article is to inform retired LASD sworn personnel of the current Department procedures to certify them under the Law Enforcement Officers Safety Act of 2004 (LEOSA), commonly referred to as HR 218. This federal law allows honorably retired law enforcement officers to carry a concealed firearm nationwide but requires annual proficiency certification. The LASD Weapons Training Unit has developed a firearms test for those retired members who wish to take advantage of the privileges afforded to them under the law.

#### **ANNUAL TESTING**

LEOSA requires the testing to be conducted by a certified firearms instructor qualified to conduct a firearms qualification test for active-duty officers within the state in which the retiree resides *or* by the agency they retired from. Retirees not obtaining LEOSA testing from LASD should use caution and ensure that they are meeting legal requirements.

The Department's firearms proficiency test for retirees assesses general firearms safety and proficiency in handling and firing weapons. It is available to any retired LASD deputy who retired in good standing. California residency is not required,

# WHOM TO CALL WHEN A SPOUSE DIES

When a spouse dies, the last thing you need is confusion about whom to contact. Filing this checklist may help keep a sorrowful event from becoming even more painful. The order in which you place the calls is not important.

- → Mortgage company

Don't forget to call extended and distant family members and friends as well. If you are simply too overwhelmed, you can avoid hurting others' feelings by asking someone to do this for you.

but the retiree must possess an unexpired LASD Retired identification card.

The Biscailuz Center Armory no longer conducts LEOSA testing. Testing is conducted at the Rio Hondo Community College on the Police Academy Range by Sheriff's Department personnel. This testing is conducted as funding permits. LEOSA testing is also conducted at the LASD Weapons Training Center at the Pitchess Detention Center. LASD Weapons Training Unit staff may not have a current list of available range dates. For a current list of available range dates and times, visit *lasdretired.org/calendar*.

LEOSA testing is also conducted by LASD Weapons Training Unit staff during the annual Retiree Roundup in Laughlin, Nevada; however, the Department will not provide ammunition for testing in Nevada.

Retired personnel who successfully complete the firearms proficiency test will immediately be issued a certification card, which is valid for one year from the date of certification. Retirees must carry this card with their Department identification.

#### ADDITIONAL INFORMATION

- As a retiree, be familiar with LEOSA and review the law in its entirety at 18 U.S.C. §§, 926C.
- The Sheriff has directed that the firearms proficiency test and annual certification be provided at no cost to LASD retirees. You will need to bring your own ammunition. Due to changes in California law, the Department is no longer allowed to sell ammunition.
- Retirees who do not wish to carry a concealed firearm outside of California do not have to qualify under the federal law. However, if they wish to continue carrying in California only, they must renew their LASD Retired identification card with CCW endorsement through Personnel Administration as currently required every five years. The Weapons Training Unit has nothing to do with that process.
- Only LASD retirees can be LEOSA-certified by the LASD Weapons Training Unit. No retirees from other agencies will be certified.
- LEOSA allows LASD retirees living in other states to be tested and issued a certificate by that state if the state offers such a test. Retirees living out of state may contact their local law enforcement agency to determine if such a test is available. Be sure their qualification meets LEOSA requirements.
- LEOSA testing may be limited due to public health orders and/or funding.



# PPOA Is Proud to Support LASD Teens in Leadership Program at Camp Pendleton

pproximately 300 teenagers from California, Nevada, New Mexico and Utah graduated from the Devil Pups Youth Leadership Program at Marine Corps Base Camp Pendleton in July. The Sheriff's Department sent 20 young men and eight young women, for a total of 28.

This year was very special, as it was a celebration of the program being in existence for 70 years. Since 1954, the Devil Pups Program has helped teenagers gain self-confidence and leadership skills through mental and physical challenges, teamwork, discipline and education.

Each year, the Department tests teenagers ages 14 to 17 on the last Sunday in April at Biscailuz Center. The program continues to be free to boys and girls who are sponsored by Department members, sworn, civilian, active or retired. We can sponsor and send exemplary teenagers to this 10-day citizen leadership program because of generous support from:

Devil Pups learn to overcome their fears and self-doubt by working together to tackle challenges and leave ready to take on life's many challenges. Camp participants complete 10 days full of tasks, like working up from a 1-mile run to a 5.5-mile beach run, 15- and 25-foot tower jumps into a swimming pool, and the legendary hike up "Old Smokey," a mountain overlooking Camp Pendleton and the Pacific Ocean.





All those who successfully graduate from the Devil Pups Youth Leadership Program are winners. We sent 28 great Pups. Of special note, Calista Lopez received 3rd Platoon Honor Pup and Ruby Rodriguez (Industry Explorer) won the Persistence Award. Ashar Baker (CV Explorer) earned the highest physical fitness score of all our Department's 28 Devil Pups, receiving 375 points out of 400.

The program was created as a better way for teens to spend part of their summer in a military environment. U.S. Marines were referred to as "Devil Dogs" in World War I by enemy troops for their battlefield accomplishments and their "never give up" spirit. The Devil Pups name is descended from the rich Marine Corps heritage.

The program's goal remains the same as it was in 1954: To develop better citizens, based on their philosophy of "Growth Through Challenge."



# PPOA Member Honored for Saving Life of Driver in Fiery Crash

n an August evening in 2023, Sergeant Collin Reddy was on patrol in Lancaster when he saw a sudden power outage. He soon came upon the source of the outage: a single vehicle was on fire and overturned on an electrical box. The driver of that vehicle was trapped inside.



Sergeant Reddy called for backup and Deputy Jeremiah

Nurse arrived swiftly. Aware that every second was crucial, both men leapt into action, despite the intensifying heat and potentially explosive danger. "We knew we had to get him out," Sergeant Reddy told KABC7. "We just went in."


Body-worn camera footage revealed flames consuming the vehicle as the driver began yelling. Sergeant Reddy and Deputy Nurse yanked the man from his car and dragged him a safe distance away from the intense inferno. "We were put there at the right place at the right time," Sergeant Reddy said.

The valor and courage required to save the life of that citizen were acknowledged last month by Congressman Mike



Garcia during a Community Town Hall meeting. Sergeant Reddy and Deputy Nurse were presented with Community Champion Awards and acknowledged by hundreds in attendance, including PPOA President Steve Johnson. The two men also had the distinction of being the first recipients of this award, which is planned to be bestowed upon first responders on a quarterly basis. •



# Paying for College and Retirement

ost parents want to do what they can to give their kids a great start in life. But is it smart to take on children's educational debt with your own retirement around the corner?

It can be, according to Sue Tirukonda, a certified financial planner with Financial Benefits in Wichita, Kansas. "Where I struggle is when you've got a child that wants to go to a school that is so far out of the parents' affordability range, so they take out massive loans to finance more than 50% of the cost of education," she says.

For example, it would take 10 years and \$846 a month, or 25 years and \$536 a month, to pay off \$70,000 in Parent PLUS direct loans from the federal government.

As a rule, Joe Orsolini cautions parents against PLUS loans. The certified financial planner with College Aid Planners in suburban Chicago explains that the government does not consider a parent's ability to repay the loans, so parents with

modest incomes but good track records could take on more debt than they can afford.

Other parents decide to delay retirement to repay loans, but unforeseen job losses or health issues can undermine those plans. Like other student loans, PLUS loans are not dischargeable in bankruptcy.

While she recognizes the risks, Tirukonda points out that PLUS loans can help with cash flow for people who earn enough to pay out of pocket but not in a lump sum at the start of each semester.

The problem, Orsolini notes, is when parents let children choose their schools and then go about figuring out how to pay for them. Instead, he says, the money discussion should happen long before applications go out.

"Parents need to let their kids know what they can afford to pay for college," Orsolini says, "and they need to let them know early in the process."

If you are trying to figure out how to pay for your child's education, the loan representatives at POPA Federal Credit Union can guide you. You can also schedule an appointment with POPA FCU's financial advisor in partnership with LPL Financial, Pam McKenzie, and inquire about what options are available to help save for your child's college tuition. She can advise what types of loans best suit you and your family.
